COMPULSORY ACQUISITION ORDER FOR THE PURPOSES OF SECTION 14 OF THE
DERELICT SITES ACT 1990 (as amended)

KILDARE COUNTY COUNCIL NO.2 AND NO. 3 ABBEY ROAD, NAAS CO.KILDARE W91FHV1, W91 E5R9 COMPULSORY ACQUISITION ORDER NO.4 2025

WHEREAS in pursuance of Part 2 of the Derelict Sites Act 1990 (as amended), in particular Section 14, **KILDARE COUNTY COUNCIL** (hereinafter referred to as the "**Local Authority**") have decided to effect the acquisition of the land to which this order relates under the Derelict Sites Act 1990 (as amended).

NOW THEREFORE it is hereby ordered that:

Subject to the provisions of this order, the Local Authority is hereby authorised:

to acquire compulsorily pursuant to its powers contained under the Derelict Site Act, the lands described in the Schedule hereto, which land is shown on a drawing marked "25-010" No.2 and No. 3 Abbey Road, Naas Co.Kildare W91FHV1, W91 E5R9, Compulsory Acquisition Order, Deposited Map and sealed with the seal of the Local Authority and deposited at the offices of the Local Authority.

The lands are described in the Schedule hereto and are shown on drawing marked: 25-010.

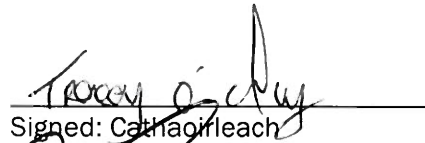
Description of the Derelict Site proposed to be acquired.

A derelict site comprising 2 derelict premises and surrounding land at No.2 and No. 3 Abbey Road, Naas Co.Kildare W91FHV1, W91 E5R9 0.04 hectares or thereabouts. The said property and surrounding land is in a state of dereliction. The said derelict site is more particularly shown outlined in RED on map bearing reference 25-010 and is entered on the Derelict Site Register established and maintained by Kildare County Council under section 8 of the Derelict Site Act 1990 (as amended) being all the property comprised in the Register of Deeds Co. Kildare.
